Bhimeshwor Municipality, Office of the Municipal Executives *has allocated funds* for the Construction of Covered Hall and intends to apply eligible bidders for the same. Bidding is open to all eligible as per Section V of bidding document.

 Bhimeshwor Municipality, Office of the Municipal Executives invites bids from eligible bidders for the construction of Covered Hall Nirman under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: [NRs 67.00 Million]
- 2. Minimum Work experience of similar size and nature: 1 (One) Similar Building (Covered Hall) within the last three (3) years, with a value of at least NRs 54 Million.
- 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

An eligible bidder wishing to e-bid are supposed to submit a *copy* of payment of a nonrefundable fee of **NRs. 5,000.00** within 30 days from publication of notice in the following details and the bidders should submit copy of company/firm registration certificate, tax clearance certificate of previous fiscal year.

Bids must be valid for a period of 120 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid\amounting to a minimum of NRs. 1,900,000.00 which shall be valid for 30 days beyond the validity period of the bid.

- 8. Matters not covered by this Notice shall be according with the Public Procurement Act 2063 and Public Procurement Regulation 2064.
