Bhimeshwar Municipality, Office of the Municipal Executives **has assisted e-Bidding procedure for the construction of Office building of Milijuli Saving and Credit Co-Operative Ltd.** Bidding is open to all eligible as per Section V of bidding document.

1. **Bhimeshwar Municipality, Office of the Municipal Executives** invites electronic bids from eligible bidders for the construction of Office building of **Milijuli Saving and Credit Co-Operative Ltd. Bhawan Nirman** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 5 years: **[NRs 48.00 Million]**
 - Participation as Prime Contractor, Management Contractor or Sub Contractor with in **Five (5) Years of Commercial Building with Basement and Raft Foundation**
 - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a **commercial Building with total floor area of 4000 Sq. Ft.**
 - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a **commercial Building with 150,000 Kg Reinforcement works**
 - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a **commercial Building with 650 cum. Of Concrete Works**

5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **4th February, 2020, 14:00 PM** at the office of **Bhimeshwar Municipality**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid\amounting to a **NRs. 1,600,000.00** which shall be valid for 30 days beyond the validity period of the bid.
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
7. Matters not covered by this Notice shall be according with the Public Procurement Act 2063 and Public Procurement Regulation 2064.
