Bhimeshwor Municipality, Office of the Municipal Executives has allocated funds for the Construction of Covered Hall and intends to apply eligible bidders for the same. Bidding is open to all eligible as per Section V of bidding document.

1. **Bhimeshwor Municipality, Office of the Municipal Executives** invites electronic bids from eligible bidders for the construction of Office building of **Tundikhel Starounnati** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 5 years: **[NRs 89.00 Million]**
 - Participation as Prime contractor in at least **1 (One) football Stadium of viewing capacity 3500 persons with RCC Parapet** Contracts within the **last 5 (Five) years**, each with a value of at least **NRs 95 Million**
 - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a **Building with 150 MT Reinforcement works**
 - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a **Building with 1000 cum. of Concrete Works**
 - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a **Building with 350 cum. of Brick Works**

An eligible bidder wishing to e-bid are supposed to submit a copy of payment of a nonrefundable fee of **NRs. 10,000.00** within 30 days from publication of notice in the following details and the bidders should submit copy of company/firm registration certificate, tax clearance certificate of previous fiscal year.

4. Pre-bid meeting shall be held at **Bhimeshwor Municipality** at **13th February, 2020, 14:00 PM**
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **23rd February, 2020, 14:00 PM** at the office of **Bhimeshwor Municipality**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid amounting to a **NRs. 3,000,000.00** which shall be valid for 30 days beyond the validity period of the bid.
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
7. Matters not covered by this Notice shall be according with the Public Procurement Act 2063 and Public Procurement Regulation 2064.
