The Sealed Quotations will be opened in the presence of Suppliers' representatives who choose to attend at 12th February, 2024, 2:00 PM at the office of Bhimeshwor Municipality, Charikot, Dolakha. Sealed Quotations must be valid for a period of 45 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 14,000.00, which shall be valid for 30 days beyond the validity period of the bid. If Suppliers wishes to submit the bid security in the form of cash, the cash should be deposited in the account as specified below and should submit Receipt/Voucher of deposited amount of cash along with Bid.
