- 5. Electronic bids must be submitted to the office Bhimeshwor Municipality, Charikot, Dolakha through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 18<sup>th</sup> February, 2024, 13:00 PM. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 18th February, 2024, 14:00 PM at the office of Bhimeshwor Municipality, Charikot, Doiakha. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 2,75,000.00, which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the bid security in the form of cash, the cash should be deposited in the account as specified below and should submit Receipt/Voucher of deposited amount of cash along with Bid.
