

1. **Bhimeshwar Municipality, Office of the Municipal Executives** invites electronic bids from Nepalese eligible bidders for the construction of **5 Number Ward Karyalaya Bhawan Nirman** under National Competitive Bidding procedures. 5. Electronic bids must be submitted to the office Bhimeshwar Municipality, Charikot, Dolakha through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **18th February, 2024, 13:00 PM**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **18th February, 2024, 14:00 PM** at the office of **Bhimeshwar Municipality, Charikot, Dolakha**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 3,60,000.00**, which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the bid security in the form of cash, the cash should be deposited in the account as specified below and should submit Receipt/Voucher of deposited amount of cash along with Bid.
