Bhimeshwor Municipality has received a grant from Nepal Telecommunication Authority towards the cost of Supply, Delivery, Installation, Commissioning and Testing of broadband services in designated locations of Municipality, Ward Offices, Community Health Centers and Community school of Bhimeshwor Municipality and intends to apply part of the funds to cover eligible payments under the Contract for BMP/NCB/GOODS/2078-079/E/15.

Bidding is open to all eligible Bidders.

1. The Bhimeshwor Municipality invites electronic bids from eligible bidders for the procurement of Supply, Delivery, Installation, Commissioning and Testing of broadband services under National Competitive bidding procedures specified in Public Procurement Act and Regulations.

4. Pre-bid meeting shall be held at Bhimeshwor Municipality, Office of the Municipal Executive at 2<sup>nd</sup> March 2022 at 14:00 PM
5. Interested Bidders shall submit the electronic Bids through [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) to the above office of Bhimeshwor Municipality on or before 12:00 PM 13<sup>th</sup> March 2022.
6. Bids shall be opened in presence of Bidders' representatives who choose to attend on 14:00 PM 13<sup>th</sup> March 2022 at the office of Bhimeshwor Municipality, Office of the Municipal Executive, Charikot, Dolakha. Bids must be valid for a period of 30 days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of NRs. 150,000.00, which shall be valid for minimum 30 days beyond the bid validity period.
7. If the last date of submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
8. Matters not covered by this Notice shall be according with the Public Procurement Act 2063 and Public Procurement Regulation 2064.
