Invitation for Bids

For the Municipality Office Building Additional Physical Improvement Work

1. The Government of Nepal has allocated funds for the maintenance of road and intends to apply these funds to cover eligible payments under the contract as stated in serial no. 12 of this notice. Bidding is open to all eligible Nepalese bidders.
2. The Bhimeshwor Municipality Office invites sealed bids submitted manually or electronic bids from registered contractors for the maintenance of road as per serial no. 12 below.
3. Eligible Bidders may obtain further information and inspect the bidding documents at the office stated below or may visit website www.bolpatra.gov.np.
4. Hard copy of the Bidding documents may be purchased from the Office of the Bhimeshwor Municipality, Dolakha by eligible bidders on or before office hours of 30th day from the first date of notice publication, on the submission of a written application and upon payment/deposition of a non-refundable fee of NRs.1000 at the account of Bhimeshwor Municipality Office, Charikot, Dolakha as following: OR

Bidders who choose to download the bidding documents from www.bolpatra.gov.np, and submit the bid electronically, the Bidders should deposit the cost (as specified above) of bidding document in the Rajaswa (revenue) Account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

5. Sealed Bids must be submitted to the Office of the Bhimeshwor Municipality, Dolakha on or before 12:00 noon of 31st day from the first date of notice publication. Documents received after this deadline shall not be accepted. Alternatively, Bidders may submit their bid electronically through <http://www.bolpatra.gov.np> within the above deadline for bid submission. The electronic bid submission system will automatically not accept e-submission of bid after the deadline.
6. The Sealed Bids and the e-submitted bids shall be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM of 31st day from the first date of notice publication at e-bidding section of Office of the Bhimeshwor Municipality, Dolakha. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by bid security or scanned copy of the bid security in pdf format in case of e-bid. Amount of bid security is as stated in serial no.12 below.
7. If a bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Deposit Account No. Ga-3/1 at Nepal Bank Limited, Dolakha in the account of Bhimeshwor Municipality Office, Charikot, Dolakha and the receipt of the deposited amount of cash or scanned copy of such receipt in pdf, format in case of e-bid should be submitted along with the bid.
8. If the last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be considered as the last day.
9. Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
10. Pre-Bid Meeting shall be held at Bhimeshwor Municipality Office, Charikot, Dolakha at 11:00 AM of 21st day from the first date of notice publication. The bidder or his authorized representative is encouraged to attend the pre-bid meeting. The purpose of the meeting is to clarify any issue regarding the bid documents and to demonstrate the process of e-submission and opening of bids.
11. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
