1. Bhimeshwor Municipality, Office of the Municipal Executives **has allocated funds, received a grant and loan** from **Town Development Fund (TDF)** towards the cost of Multipurpose Complex and intends to apply part of the funds to cover eligible payments under the Contract for **Multipurpose Building with Public Toilet**. Bidding is open to all eligible as per Section V of bidding document.
2. **Bhimeshwor Municipality, Office of the Municipal Executives** invites electronic bids from eligible bidders for the construction of **Multipurpose Building with Public Toilet** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **[NRs 191.00 Million]**
  - Minimum Work experience within five years of similar size and nature: **[Three building project ( Basements) with each value of 102 Million]**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
  4. A complete set of Bidding Documents may be purchased from the office **Bhimeshwor Municipality, Office of the Municipal Executives** by eligible Bidders on the submission of a written application, along with the *copy of company/firm registration certificate*, and upon payment of a non-refundable fee of **NRs. 10,000.00** till 12-03-2018 during Office Hours.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below.

6. Pre-bid meeting shall be held at **Bhimeshwor Municipality** at **04-28-2018 14:00**
7. Joint Venture (JV) is not applicable.
8. Sealed or electronic bids must be submitted to the office **Bhimeshwor Municipality** by hand/courier or through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 P.M.** on **13-03-2018**. Bids received after this deadline will be rejected.

9. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 13-03-2018** at the office of **Bhimeshwor Municipality**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid\amounting to a minimum of **3.2 Million** which shall be valid for 30 days beyond the validity period of the bid.
10. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
11. Matters not covered by this Notice shall be according with the Public Procurement Act 2063 and Public Procurement Regulation 2064.
