Bhimeshwar Municipality, Office of the Municipal Executives has allocated funds for **Dolakha - Nagdaha sadak starounnati Karya** and intends to apply eligible bidders for the same. Bidding is open to all eligible as per Section V of bidding document.

1. **Bhimeshwar Municipality, Office of the Municipal Executives** invites electronic bids from eligible bidders for the construction of **Dolakha - Nagdaha sadak starounnati Karya** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **[NRs. 46 Million]**
 - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing **at least One Premix Carpet Road with minimum 42 Cum quantity** within the **last 5 (Five) years**, with a value of at least **NRs 24 Million**.
 - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a **Road with 26 MT Reinforcement works**.
 - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a **Road with 500 cum. of Concrete Works**.
 - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a **Road with 250 cum. of Sub Base Works**.
 - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a **Road with 175 cum. of Base Course Works**.
 - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a **Road with 135 cum. of Random Rubble stone Masonry in cement mortar Works**.
 - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a **Road with 392 cum. of Gabion Works**.

5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **5th October, 2021, 14:00 PM** at the office of **Bhimeshwar Municipality**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid\amounting to a **NRs. 8,50,000.00** which shall be valid for 30 days beyond the validity period of the bid.
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
7. Matters not covered by this Notice shall be according with the Public Procurement Act 2063 and Public Procurement Regulation 2064.
