Bhimeshwar Municipality, Office of the Municipal Executives has allocated funds for **for Construction of Thami Sangrahalaye** and intends to apply eligible bidders for the same. Bidding is open to all eligible as per Section V of bidding document.

1. **Bhimeshwar Municipality, Office of the Municipal Executives** invites electronic bids from eligible bidders for the construction of **for Construction of Thami Sangrahalaye** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 5 years: **[NRs. 45 Million]**
 - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing **at least One RCC Framed Structured Building with minimum total floor area 5,000 Sq. ft. within the last 5 (Five) years**, with a value of at least **NRs 48 Million**.
 - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a **Building with 76 MT Reinforcement works**
 - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a **Building with 655 cum. of Concrete Works**
 - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a **Building with 30 cum. of Brick Works**
 - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a **Building with 150 cum. dressed stone masonry works**.

5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **8th August, 2021, 14:00 PM** at the office of **Bhimeshwar Municipality**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid\amounting to a **NRs. 18,00,000.00** which shall be valid for 30 days beyond the validity period of the bid.
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
7. Matters not covered by this Notice shall be according with the Public Procurement Act 2063 and Public Procurement Regulation 2064.
