1. The Government of Nepal (GoN) has allocated TB-SWAp funds to Bhimeshwor Municipality for Steel Parts Fabrication and the Municipality intends to apply the funds to cover eligible payments under the Contract for supply of fabricated steel parts for Trail Bridges. Bid is open to all eligible Nepalese Bidders.
2. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by www.nepaltrailbridges.org.np may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.
3. Eligible Bidders may obtain further information at the office of Bhimeshwor Municipality and inspect the bidding documents or www.bolpatra.gov.np
4. An eligible bidder wishing to bid are supposed to submit a copy of payment of a non-refundable fee of NRs. 1,000.00 within 7 days from publication of notice in the following details and the bidders should submit copy of company/firm registration certificate, tax clearance certificate of previous fiscal year.

5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1st June, 2020, 13:00 PM at the office of Bhimeshwor Municipality. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid\amounting to a NRs. 30,000.00 which shall be valid for 30 days beyond the validity period of the bid.
6. If bidder wishes to submit the Cash Security, the cash should be deposited in Account No. 13003000003000000003 at Nepal Bank Ltd., Charikot, Dolakha, and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
